**Government Order**

2. Terms and Conditions:

- a. The officer will not be allowed to stay abroad more than the approved period;
- b. He will inform the authority immediately after his return;
- c. He will draw his pay and allowances in local currency. No part of it could be drawn in foreign currency;
- d. All related expenses of the travel will be borne by himself;
- e. If it is necessary to take extra leave in addition to the approved period the authority has to be informed through the concerned Embassy/High Commission as per the rules;
- f. The Provision of Rules 34 of Appendix VIII of BSR (Part-1) is applicable in this regard. That is to say, the officer has to start his leave within the 35 (thirty five) days from the date of this order as this order will not remain in force after the 35 (thirty five) days from the making thereof; and
- g. Travelling expenses will have to be shown in his income tax return.
