

**Government Order**

Mrs. Suma Bhowmick, Junior Instructor (Non-Tech), Dhaka Polytechnic Institute, Dhaka (Passport No. OC 3236213) has been granted Ex-Bangladesh (earned leave) for travelling to India for 21 (twenty one) days starting from 26.12.2021 to 15.01.2022 or from the date of travelling. This leave is granted for the purpose of his son's medical treatment under the following terms and conditions:

- a. The officer will not be allowed to stay abroad more than the approved period;
  - b. She will inform the authority immediately after her return;
  - c. She will draw her pay and allowances in local currency. No part of it could be drawn in foreign currency;
  - d. All related expenses of this travel will be borne by herself;
  - e. If it is necessary to take extra leave in addition to the approved period the authority has to be informed through the concerned Embassy/High Commission as per the rules;
  - f. The Provision of Rules 34 of Appendix VIII of BSR (Part-1) is applicable in this regard. That is to say, the officer has to start his leave within the 35 (thirty five) days from the date of this order as this order will not remain in force after the 35 (thirty five) days from the making thereof; and
  - g. Travelling expenses will have to be shown in his income tax return.
